

puchea. Each party's candidate for the provisional government should be proposed by the party itself and should also be acceptable to the other parties concerned.

(iii) Upon establishment of the Provisional Quadripartite Coalition Government of Kampuchea, a freeze should be imposed on Kampuchea, forces of all factions and these forces should refrain from getting involved in politics and interfering in the general election, so that the Kampuchean people may conduct a free election without outside interference and threat of force.

(iv) Practical and effective international supervision should be instituted over Vietnamese troop withdrawal, the maintenance of peace in Kampuchea, and the conduct of free election. If concerted parties reach an agreement on a political settlement of the Kampuchean question, China will be ready to join other countries in an international guarantee for an independent, neutral and non-aligned Kampuchea.

The Chinese proposal is one of several proposals which have been made for finding a solution to this problem.

(c) to (e) India has diplomatic relations with the People's Republic of Kampuchea and a dialogue is maintained with that Government. The People's Republic of Kampuchea have rejected the Chinese proposal. They support the initiative proposed to be taken by some selected non-aligned countries (including India) on this problem. We would like a politically, negotiated settlement which will lead to the establishment of a peaceful, independent, sovereign and non-aligned Kampuchea.
