

crossed the North and Western Africa and leached Sudan and there is a possibility of some groups of locusts reaching India from the west.

(c) (i) Constant vigilance is being kept on locust activity in the Scheduled Desert Area;

(ii) Regular interaction is being maintained between the Locust Control Organisations of India Pakistan and the PAO;

(iii) The State Governments concerned have been alerted;

(U) Locust Warning Organisation has been geared up through mobilisation of manpower, vehicles, equipment, poaticides etc.; and

(v) A detailed contingency plan has been drawn up for the deployment of men and material at startegic locations to tackle any emergent situation.

#### **Recruinment of handicapped in Central Services**

1365. SHRI PAWAN KUMAR BAN-SAL: Will the Minister of WELFARE be pleased to state:

(a) whether Government have formulated a special time bound Programme to recruit handicapped persons in Central Services recently. -

(b) if so, what are the details thereof and the percentage fixed in this regard; and

(c) whether any guidelines and instructions have been issued to the various departments to expedite the recruitment in favour of such persons?

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRIMATI SUMATI ORAON): (a) Yes, sir.

(b) Government of India have reserved 3 per cent vacancies for the physically handicapped in Group C & D posts in Central Government Ministries/Deptts.

and cooperable posts in Central Government Public Sector Undertakings. The reservations are 1 per cent each for tht blind, deaf and for the orthopaedically handicapped. Special recruitment of blind and deaf persons has been done against backlog of vacancies available in Delhi in Central Government Ministries/ Deptts. in respect of Group C & D posts.

An attempt is being made to fill up the backlog of vacancies in Offices out side Delhi by 31.12.1988 in respect of the blind and the deaf.

(c) Guidelines and instructions havs been issued from time to time to various Ministries/Departments to expedite the recruitment of the handicapped.

#### **Promotion of Cashew Nut Cultivation**

1366. DR. ABRAR AHMED KHAN: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government propose to set up a Cashew Nut Board to promote Cashew Nut Cultivation processing and export as an integrated operation in view of the potential of this high value crop; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI SHY AM LAL YADAV): (a) No decision has been taken as yet to set up a Cashewnut Board.
