(b) Fishing vessels of 13.7-M in length and above and fitted with engine of net less han 150 HP are entitled to get excise duty rebate of 50 per cent on high speed diesel. Additional rebate of 50 per cent of excise duty on each 1.08 KL of diesel oil is also allowed for every one tonne of prawn exported. Moreover duty free high speed diesel is also permitted to deep sea fishing trawlers approved as 100 per cent Export Oriented Units.

## Measures to check over-fishing on West Coast

The expert view is that shrimp resources along the coast is exploi'ed at the maximum sustainable yield levels. No further increase in fishing pressure by trawlers etc. is recommended. A Committee and a working group constituted at the national level by the Government of India during 1986 and 1987 respectively have recommended several measures for conservation of shrimp and prevention of over fishing. The reports of the Committee and the Working group are under examination.
