New Instruments for PCOs

4485. SHRI RAMSINH RATH-WA: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that the rates of calls made from Public Call Office have been increased from 0.50 paise to one rupee;
- (b) whether it is a fact that when particular instrument is full of coins a local call can be made free;
- (c) at what interval PCO instruments are emptied; and
- (d) by when new instruments will be installed with changed design?

THE MINISTER OF COMMUNICATIONS (SHRIBIR BAHADUR SINGH): (a) Yes, Sir.

The Charges for local call made from public call offices in measured rate exchange have been increased from 0.5) paise to one rupee with effect from 1-4-1988.

(b) No, Sir.

(c) The frequency of clearing the cash boxes is fixed depending on the calling rate of the PCO. It may be weekly, bi-weekly, fortnightly or monthly.

(d) The production of new type PCOs which can be operated by inserting Re. 1 coin has already commenced. These will be introduced progressively.

Improving Rural Communication Services

4486. SHRI RAMSINH RATHWA: Will the Minister of COMMUNICATIONS be pleased to state:

THE MINISTER OF COM-MUNICATIONS (SHRI BIR BAHADUR SINGH): (a) Small capacity electronic exchanges have been designed by C-DOT & ITI for rural areas which can afford these facilities provided reliable transmission medium is available.

- (b) Supplies have just commenced. No such exchange has so far been commissioned in the State of Gujarat. However, from existing electro mechancial exchanges, a total of about 30,000 rural telephone connections are working.
- (c) There are 6180 applications in waiting list for telephone connections in rural areas of Gujarat as on 31-3-1988.

- (e) The Department of Telecommunications propose to use mostly indigenously developed exchanges in rural areas of the country.
