### **Notification on Fixed Term Employment**

2365. SHRI PRASANTA CHATTERJEE: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) whether in the tripartite meeting held on 21st June, 2006, the issue of Fixed Term Employment was discussed and Trade Unions insisted on issuing the final notification immediately as per notification dated 30th September, 2004;

(b) if so, the action taken by Government;

(c) whether minutes of the meeting have been circulated; and

(d) if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI OSCAR FERNANDES): (a) to (d) A meeting with the employers and employees was held on 21st June, 2006 under the Chairmanship of Secretary, Labour & Employment, to discuss the issues with regard to amendment to the Industrial Employment (Standing Orders) Act, 1946. In the meeting, representatives of the Trade Unions insisted on issuance of the final notification dated 30th September, 2004. However, the employer representatives favoured its retention. A record of discussions of the proceedings of this meeting has been kept for further consideration of the matter. Final decision in this regard is yet to be taken.

### **Education and vocational training to child labourers in M.P.**

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI OSCAR FERNANDES): (a) and (b) Under the Scheme of National Child Labour Project (NCLP), children withdrawn from the work are put in the special schools, where these children are provided with education, vocational training; stipend, nutrition and health checkup facilities etc. At present, scheme is being implemented in 17 districts of Madhya Pradesh covering 29000 children. In addition, an INDUS project, which is a joint project of Government of India and US—Department of Labour, is also being implemented in 5 districts of the State for covering 10,000 child labour. Details of the districts covered are given in the Statement.
