Rise in prices of essential Commodities

1680. SHRIMATI SUDHA VIJAY JOSHI, Will the Minister of FINANCE be pleased to state:

- (a) whether Government are aware of the recent report about continuing rise in the prices of essential commodities and in the inflation rate; and
- (b) if so, what steps are being taken to curb the prices rise and inflation?

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC FAIRS IN THE MINISTRY **O**F FINANCE (SHRI EDUARDO) FALEI-RO): (a) The prices generally come under pressure during the first half of the financial year due to seasonal factors. Wholesale Price Index has recorded increase of 3.4 per cent since the end of March, 1988 upto 23rd July, 1988 which is the lowest rate of increase for period in several years. While the prices of some items like rice, pulses and sugar have gone up, those of others like wheat and edible oils have registered a decline.

(b) The measures taken to curb the price rise include steps to optimise food-grains production, strengthening of the Public Distribution System, imports and release of essential commodities like pulses and edible oils, strict economy in government expenditure, restraint on money supply growth selective credit controls and intensive action against profiteers and hoarders.

Treaty on Disclosure of illegal assets of Indians in Swise banks
