Raids against tax evaders

1762. SHRI V. NARAYANASAMY: Will the Minister of FINANCE be plea sed to state:

- (a) what is the number of raids con ducted by Government against tax eva ders and Government officials during the last six months:
- (b) what is the total amount of money movable and immovable assets found without proper accounts in respect of the above categories of persons; and
- (c) whether Government have any proposal to introduce any amnesty scheme this year so that tax evaders come forward and disclose their income; if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA): (a) During the period 1.1.1988 to 30.6.1988, the Income tax Department conducted 3545 searcheg.

- (b) The "searches mentioned above resulted in seizure of unaccounted assets, including cash and jewellery, and a large number of incriminating documents. The aggregate value of the seized assets Is about Rs. 85.27 crores. During these searches concealment of income to the tune of Rs. 119.51 crores was admitted by the persons searched.
- (c) No such proposal is under consideration by the Government.

Production of Mulberry raw silk

1763.SHRI V. NARAYANASAMY: Will the Minister of TEXTILES be pleased to state;

- (a) whether Government have plans to increase the production of mulberry raw silk to 8000 tonnes a year because of the heavy demand in foreign coun tries for the raw silk;
- (b) what is the total amount to be spent for increasing the production of raw silk; and
- (c) what facilities Government are providing to the formers who are in volved in mulberry production?

THE MINISTER OF TEXTILES (SHRI RAM. NIWAS MIRDHA); (a) Production of mulberry silk in the country has already reached the level of 8400 tonnes in 1987-88. The Production target set for the end of the VII Plan period for mulberry raw silk is 9980 tonnes:

- (b) The Planning Commission have approved an allocation of Rs. 240 crores for, State Sector and Rs. 70 crores for Central Sector for sericulture deve lopment during the VII Plan period.
- (c) Central Government, through the Central silk Board, supplements the efforts of State Governments by providing the following assistance to the farmers involved in mulberry production:
 - (i) Supply of high yielding varieties of mulberry cuttings at subsidised rates.
