Plight of Punjab Migrants living in Delhi

- (b) whether proper facilities are not being provided to them; and

THE MINISTER OF STATE IN THE MINISTRY OF HOME **AFFAIRS** (SHRI SANTOSH MOHAN DEV): (a) to (c) A total number of 6500 families comprising 27,516 members have reported in the Office of the Deputy Commissioner Delhi till 26-7-1988. Out of these 579 families with 2608 members have gone back to Puniab.

It is not correct to say that the Punjab migrants are living in pitiable conditions in Delhi. Various facilities are being provided by Delhi Administration to them. They are being given financial assistance for food at

the rate of Rs. 10/- per member per day subject to a maximum 1000/- per family per month. families are being provided free accommodation, depending upon availofficial camps free ability. In the electricity, water and medical facilities are being provided. Assistance ance in the admission of children in various schools is also given.

Alleged gang rape by Assam Rifles Jawans

(b) According to information furnished by the State Government, preliminary enquiry was conducted into allegation of mass rape by Assam Rifles men at Ujanmaidan published in Daily Deshar Katha on 5-6-1988. The allegation was not established by any evidence/documents. The women were alleged to have been raped who were asked to undergo medical examination by a Lady Doctor but they refused to do so.
