- (b) to (d) The National Policy on Education 1986 reiterates equality of sexes. To achieve this objective, among others, the National Council of Educational Research and Training has developed a national curricular framework. The National Council has taken several steps in this regard. Under a scheme sponsored by NCERT for the reorientation of the content and process of education, financial and academic assistane is being extended by NCERT to the State Textbook Boards, State Councils of Educational Research and Training, Boards of Secondary Education and other bodies for reviewing the existing textbooks and also for the preparation of revised manuscripts in conformity with the National Policy on Education and the National Curricular Framework circulated by NCERT. NCERT has undertaken the following academic activities for removal of sex bias from tha school textbooks and other instructional materials:
