A majority of the training centres for ICDS anganwadi workers are run by voluntary organisations. In March 1988, the State Governments were advised, to consider entrusting such centres with the responsibility of actual running of a certain number of anganwadis in their respective areas.

It is for the State Governments to decide to what extent competent voluntary organisations are available in their areas and how far those organisations can be entrusted with implementation of ICDS projects or parts thereof.

## Non-Availability of School Text Books in Tamil Nadu

## Inauguration of MGR University

- (a) whether it is a fact that the inauguration of M.G.R. University

was postponed due to sudden demise of Dr. M.G. Ramachandran on 24th December, 1987;

- (c) by when the University is likely to be inaugurated?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE-DEVELOPMENT (SHRI L. F. SHAHI); (a) and (b) The Dr. M.G.R! Medical University, Tamil Nadu, Act 1987 came into force on 24-9-1957. Tie Act provided that the first Vice-Chancellor and the first Registrar shall be appointed by the State Government within three months from the date of the publication of the Act. However, due to various reasons, including the death of then Chief Minister, these appointments could not be made and the University did not become operational by the appointed date.

(c) The date by which the University would become operational is being ascertained from the State Government and will be placed on the Table of the House.
