**Inadequate berths in Kolhapur-Mahalaxmi Train**

1853. **SHRI A. G. KULKARNI:** Will the Minister of RAILWAYS be pleased to state:

(a) whether Government have received complaints from trading community and passengers' Associations regarding inadequate provision of upper class berths for Kolhapur, Miraj, Sangli Stations in Kolhapur-Mahalaxmi Train, running upto Bombay; if so, what are the reasons therefor;

(b) whether the old bogies attached to Kolhapur-Mahalaxmi when this train was inaugurated, are still continuing; if so, whether Government have received any complaints regarding rickety berths and filthy latrines; and

(c) whether Government have received proposals to transfer the sector between Kolhapur to Pune to Central Railway; if so, what is Government's reaction thereto?

**THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA):** (a) Yes, Sir. Some representations have been received. Additional reservation quota of Three AC 2-tier and Two First Class berths has since been provided at Miraj for Bombay in Mahalaxmi Express from 21.5.88.

(b) No, Sir. No overaged or overdue POH coaches are running on Kolhapur-Mahalaxmi Express. Only one complaint has been received during the current year.

(c) Some suggestions to transfer Pune-Kolhapur section from South Central Railway to Central Railway have been received and the same have been noted.
