on account of not having sufficient trans-shipment hubs. However, the objective is to reduce the transaction cost for Indian trade. Under the National Maritime Development Programme (NMDP), a total of 276 projects have been identified including projects for deepening of channels and development of container terminals/berths in various Major Ports to be taken up for implementation over the period upto 2011-12. This is a part of an on-going process keeping in view the demands of the maritime trade.

Development of Ports in Kerala

(a) while the fast development of Kochi Port including the two areas Vallarpadam and Puduvypeen are welcome, what are the reasons for the same tempo missing in developing Colachal and Cuddalore ports;

(b) the bottlenecks in speeding up the development of these ports if there are any bottlenecks when they can be got over and the development can go at good speed; and

(c) would there be a time frame to complete the development of these ports entirely?

THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R .BAALU): (a) to (c) Development of ports is an ongoing process keeping in view the demands of maritime trade. While developing the major ports including Cochin Port, the Central Government's endeavour is to encourage the process of development of the non-major ports, which are under the jurisdiction of respective State Governments including Colachal and Cuddalore ports in the State of Tamil Nadu.

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI K.H. MUNIAPPA): (a) and (b)The stretch of National Highway from Delhi to Meerut is already four-laned. Meerutto Muzaffarnagar stretch has already been awarded for four-laning and work is in progress. Bids for four-laning of National Highway-58 from Muzaffarnagar to Haridwarareto be invited once again by National Highways Authority of India on Build Operate Transfer (BOT) basis. It is premature to indicate the completion date of four-laning of National Highway-58, up to Haridwar at present.

(c) Keeping in view the heavy traffic, preparation of Detailed Project Report for six-laning of Delhi/Uttar Pradesh Border to Meerut section of National Highway-58 has been taken up under National Highway Development Project Phase-Ill-A.

(d) This Ministry is responsible for development and maintenance of National Highways. Widening of National Highway-58 is proposed to facilitate traffic movement on it to Haridwar.
