

(b) if so, what steps have been taken to correct the situation?

THE MINISTER OF PLANNING AND THE MINISTER OF PROGRAMME IMPLEMENTATION (SHRI MADHAVSINH SOLANKI): (a) Yes, Sir.

(b) Government have taken various steps of which mention could be made of the following:

- Intensive monitoring of projects by the Ministry of Programme Implementation through monthly/quarterly monitoring system;
- Setting up of Task Force/Empowered Committees for problem solving and speedy implementation of projects;
- In-depth periodical review of progress of projects by administrative Ministries and constant pressure on project authorities for expeditious completion;
- Close follow-up by concerned Ministries and project authorities with State Government, equipment suppliers, contractors, consultants and other concerned agencies to minimise delays;
- Inter-ministerial coordination and interaction;
- Issue of directions for ensuring continuity of tenure of project head until the completion of project and 2—3 years beyond to ensure accountability for implementation.

Defence collaboration with U.S.A.

2055. SHRI CHITTA BASU: Will the Minister of DEFENCE be pleased to state:

(a) whether there is any proposal under Government's consideration for defence collaboration with U.S.A. and her western allies; and

(b) if so, the details thereof?

THE MINISTER OF DEFENCE (SHRI K. C. PANT): (a) and (b) It is proposed to expand defence cooperation along the lines which have already been established in working together with the United States of America on certain Defence related technologies, such as Light Combat Aircraft (LCA) Project. It is also proposed to explore and identify other areas of Defence cooperation. It will not be in the national interest to disclose further details.

XMP—14 Super Computer

2057. SHRI CHITTA BASU: Will the PRIME MINISTER be pleased to refer to answer to Unstarred Question No. 1057 given in Rajya Sabha on the 3rd March, 1988 and state:

(a) whether the commercial negotiations with the manufacturers of XMP-14 Super Computer have since been completed;

(b) whether all arrangements regarding the purchase of the super computer have since been finalised; and

(c) if so, the details of the arrangements?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND THE MINISTER OF STATE IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI K. R. NARAYANAN): (a) Yes, Sir.

(b) Yes, Sir.

(c) The commercial negotiations were completed and contract for purchase of the Supercomputer Cray XMP-14 was signed between the Government of India, Department of Science and Technology and M/s. Cray Research Inc., USA on 5-5-1988. On the same day, Agreement for the supply of System Software and Hardware Maintenance was also signed.

Indian reaction to shooting down of Iranian airliner in the Gulf

2058. SHRI MURLIDHAR CHANDRAKANT BHANDARE: Will the Minister of EXTERNAL AFFAIRS be pleased to state whether the Indian Representative in the U.N. Security Council supported an international enquiry into the recent shooting down of an Iranian airliner by a U.S. Warship over the Persian Gulf killing around 300 passengers and crews including Indians, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): Yes, Sir.

The UN Security Council adopted a resolution welcoming the decision of the International Civil Aviation Organisation (ICAO) to investigate the incident in its technical aspects. The Indian representative made a statement during the debate expressing India's support for the enquiry to be undertaken by ICAO.

Helicopters for Navy

2059. SHRI RAM NARESH YADAV: Will the Minister of DEFENCE be pleased to state:

(a) whether there is a proposal under Government's consideration to buy helicopters for Navy to enhance missile detection capabilities of the naval fleet;

(b) if so, what are the other programmes of Government to modernise the Navy and Air Force; and

(c) whether any agreements for the supply of the helicopters and material for construction of missile frigates, missile boats and other support vehicles has been placed with any foreign country?

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI CHINTAMANI PANIGRAHI): (a) to (c). The modernisation plan of the Indian Navy includes the enhancement of its missile detection capabilities. The modernisation of the Armed Forces is an on-going process related to the threat perception and the intended roles of the Armed Forces.
