(b) The capacity of all the Heavy Water Plants in operation is 365 MTS per annum.

Heavy Water being a strategic material, it is not in the national interest to reveal the actual production figures.

- (d) In additions to the plants in operaion, two more Heavy Water Plants, one it Manuguru (A.P.) and another at Iazira (Gujarat) are under construction. idditional plants to meet the anticipated emand are being planned,

Government has conveyed its concern to the Government of Canada and appreciates the Canadian Government's continuing cooperation in combating the international dimensions of terrorist activities directed against India.
