THE MINISTER OF STATE IN THE OF RURAL DEPARTMENT DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI JANARDHAN POOJARI); (a) Indira Awas Yojana, a subscheme of Rural Landless Employment Guarantee Programme (RLEGP) was launched during the year 1985-86. Funds are allocated to the States/UTs under the Yojana on financial year basis. During the period 1985-86 to 1987-88, an amount of Rs. 3362.00 lakhs was allocated to Andhra Pradesh for construction of houses under the Yojana.

(b) Monitoring of expenditure incurred unde<sub>r</sub> the Yojana is done on the basis of reports received from States/UTs on financial year basis. During the period 1985-86 to 1988-89 (upto June, 1988),-expenditure of Rs. 3243.415 lakhs including the value of foodgrains at subsidised rates is reported to have been incurred under the Yojana by the State.
