(d) The Multi-State Co-operative Societies Act does not lay down time limit for a multi-State cooperative society, which includes NAFED, to devise the procedures including the level and the bodies for association of its employees in the management decision making process.

This is not, however, expected to provide service to Rohru and Jubbal in view of intervening distance and terrain. Further improvement of TV service in the district would depend upon availability of resources under future plans for TV expansion in the country.
