

(क) से (घ) खाद्य तेल नीति प्रत्येक तेल वर्ष (नवम्बर-अक्तूबर) के लिए तैयार की जाती है। इसे तैयार करने में उस तेल वर्ष के दौरान देश में देशी खाद्य तेलों की उपलब्धता तथा खाद्य तेलों की मांग, अन्तर्राष्ट्रीय बाजार में खाद्य तेलों के मूल्यों तथा खाद्य तेलों के आयात के लिए विदेशी मुद्रा की व्यवस्था, आदि को ध्यान में रखा जाता है।

आयातित खाद्य तेलों के निर्गम मूल्य नियत करते समय तथा सार्वजनिक वितरण प्रणाली और वनस्पति उद्योग को उसकी मात्रा निर्भुक्त करते समय यह सुनिश्चित करने की ओर यथोचित ध्यान दिया जाता है कि उपभोक्ताओं तथा साथ ही तिलहन उत्पादकों के हित पूरी तरह सुरक्षित रहें।

Tribal land grabbed by Non Tribals

2292. SHRI SUNIL BASU RAY: Will the Minister of WELFARE be pleased to state:

(a) whether Government have any statistics about tribal land grabbed by non-tribals in the country; and

(b) if so, State-wise details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRI-MATI SUMATI ORAON): (a) and (b) Yes, Sir. State-wise details of cases of alienation of tribal land are given in the statement enclosed. [See Appendix CXLVII, Annexure No. 98].

Recovery of Brabbed Tribal Land

2293. SHRI SUNIL BASU RAY: Will the Minister of WELFARE be pleased to state what actions have been taken to recover grabbed tribal land by non tribals in the country?

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRI-MATI SUMATI ORAON): States have enacted land laws to protect the interests of tribals in land. Spe-

cial staff has been posted for detection of land alienation cases and restoration of such lands to tribals. Revenue officers in some States have also been empowered to institute suo-moto proceedings for detection and restoration of alienated land.

Restoration of the Possession of Kapurthala House Plot

(c) what are the reasons for delay in transfer of the above property?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH):

(a) to (c) Out of the total area of 6.05 acres of land at Kapurthala House Plot, 3,886 acres of land is yet to be handed over to Government of Kerala. A suitable alternative accommodation for Delhi Security Police is being located for releasing the remaining portion.
