Tribal land grabbed by Non Tribals

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRI-MATI SUMATI ORAON): (a) and (b) Yes, Sir. State-wise details of cases of alienation of tribal land are given in the statement enclosed. [See Appendix CXLVII, Annexure No. 98].

Recovery of Brabbed Tribal Land

2293. SHRI SUNIL BASU RAY: Will the Minister of WELFARE be pleased to state what actions have been taken to recover grabbed tribal land by non tribals in the country?

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRIMATI SUMATI ORAON): States have enacted land laws to protect the interests of tribals in land. Spe-

cial staff has been posted for detection of land alienation cases and restoration of such lands to triblas. Revenue officers in some States have also been empowered to institute suo-moto proceedings for detection and restoration of alienated land.

Restoration of the Possession of Kapurthala House Plot
