## Loans to rural poor of Andhra Pradesii

2467. SHRI TALARI MANOHAR: Will the Minister of FINANCE be pleased to state the bankwise and districtwise of the total loan provided to the rural poor in Aarihra Pradesh by all the nationalised banks so far?

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AFFAIRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FALEIRO): The question presumably relates to sanctioning of bank Rural loans under the Integrated Development Programme (IRDP). Reserve Bank of India (RBI) has repoited that its present data reporting system does not generate district-wise information implementation of IRDP However, data available for the State of Andhra Pradesh as a whole indicates that during the year 1986-87 as against the target of 241500 beneficiaries, the bank; had assisted 256944 beneficiaries under IRDP. During the year 1987-88 as against a target of 89909 beneficiaries, the number of beneficiaries assisted were 263559.

BIER, a qua-.i-junicial body, will decided the cases in accordance with the provisions of the above Act.
