(a) whether it is a fact that the cost of diesel and electric locos manufactured in Chittaranjan Locomotive Works is less than that of the imported ones; and

(b) if so, what are the reasons for which the Railways are importing diesel and electric locos from abroad, by neglecting the Chittaranjan Locomotive Works?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Yes, Sir.
