## Construction on Airport at Leng Pui in Mizoram

DR. C. SILVERA:

Will the Minister of CIVIL AVIA-TION AND TOURISM be pleased to state:

- (a) whether the Mizoram Govern ment propose to construct a new air port/airfield for Boeing 737 at Lengpui;
- (b) if so, when this proposal was sent to Government for approval;
- (c) whether Government and tho National Airports Authority have given their clearance to the project;
- (d) if so, what are the details thereof, and if not, by when the final decision in this regard is likely to be taken; and
- (e) whether the Mizoram Go ment has also asked for funds for the purpose; if so, what are the details thereof?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI MOTI LAL VORA): (a) to (e) The Mizoram Government does not itself propose to construct a new airport at Leng Pui. However, a suggestion has been made to the Central Government for construction of an airfield for Boeing-737 at the same place. The experts of National Airports Authority have visited the site in February, 1988 and submitted its report in March, 1988. The approximate cost for development of the airport would be to the tune of Rs. 30—35 crores, Including night landing facilities. The Government has not given any approval to this project.
