Shortfall in capacity of Civil Aviation Sector in catering the tourists

- (a) whether Government are aware of the capacity shortfall in civil aviation sector in catering to the projected number of tourists by 2000 A.D.; and

(b) to meet its immediate requirement Indian Airlines has already placed an order for 19 Airbus A-320 aircraft for delivery in 1989-90 and Air-India has placed an order for two Boeing 747-300 COMBI aircraft to be delivered in October-November, 1988.

Decline in India's share in international traffic

(a) whether it is a fact that Air India's share in international traffic to

and from India has gradually declined since 1981;

- (b) if so, what are the details of the traffic of Air India since 1981, year-wise; and
- (c) what action Government propose to take in this regard?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI MOTI LAL VORA): (a) and (b) There is a declining trend in the share of Air India's traffic to and from India. The details are as under:—

(c) The current fleet of Air India is fully utilised and Air India have achieved consistently high occupancy levels on most of its services. For augmentation of the capacity of Air India, keeping in view the traffic growth and other factors, Government has already approved the proposal of Air India for acquisition of two Boeing 747-300 (Combi) aircraft to be inducted into the fleet of Air India during 1988-89.
