The Department of Tourism undertakes the promotion and development of tourism in the country as a whole, ncluding Andhra Pradesh and Tamil Nadu. Involvement of Private Sector in the Development Of Tourism Infrastructure in Andhra Pradesh

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI MOTI LAL VORA); (a) and (b) In order to attract the private sector in building tourist infrastructure in the country, the Cenral Government has been giving certain incentives such as tax holidays under Section 80-1, exemption from MRTP Act, reduced customs duty for project imports, investment by nonresident Indians in equity capital subject to conditions laid down by the Reserve Bank of India, benefits under Section 80-HHC, etc.

These incentives are available to the private sector in Andhra Pradesh also.
