## Grants to the States for immunization Programme

- 2743. SHRI HARVENDRA SINGH HANSPAL: Will the Minister of HEALTH AND FAMILY WELFARE B<sub>e</sub> pleased to state:
- (a) whether Government have called upon the States to draw up of plan for implementation of the national mission on immunisation:
- (b) if so, what are the details of the guidelines issued in this regard;
- (c) what kind of help Government propose to render to the State Governments for effective implementation of the action plan; and
- (d) sy when the target is likely to be achieved ?
- THE MINISTER OF STATE IN THE MINISTRY OF **HEALTH** AND **FAMILY** WELFARE (KU MARI **SAROJ** KHAPARDE): (a) and (b) Yes Sir. States have been requested prepare their to action planes giving detailg of vaccine re quirement, vaccine distribution, facilites storage and testing ccines, disease surveil lance, involvement of voluntary organisations, arrangements for coverage avaluation and other items relevant to the particular situation of each State.
- (c) Additional inputs in the shape of additional staff, vaccines, equipment for storage and transportation off vaccines (such as walk-in-cool-ers, refrigerators and vaccine carriers'), items of recurrent nature such as syringes and needles and vehicles are provided to States for effective implementation of the action plan.
- (d) Target is likely to be achieved by March, 1990.

## Miraculous escape of the Air Passengers
