- (v) When selecting a newspaper or news agency the selection of the correspondent or of any other competent Journalists should he left to the editor:
- (vi) Unless the invitation is addressed to the editor personally, the editor in making the selection of the correspondent or of any other competent Journalist should avoid as far as possible selecting himself or herself an,d should not select any person not connected with the publication concerned.
- (c) The Prime Minister's visits do not come under the category of officially sponsored visits. Moreover, the Council's guidelines are only recommendatory in nature and not binding on the Government.

yield from fishing: harbour projects

The estimated landings it the 21 commissioned harbours is ibout 2.50.000 tonnes per annum.
