(a) whether it is a fact that the Statutory Audit Report of NCCF for 1986-87 was signed on the 15th February, 1988 by only two Auditors out of three and subsequently, an official of NCCF was sent to Allahabad to obtain the signature of the third Auditor;

(b) whether the Audit Report of NCCF complies with the Multi State Cooperative Societies (Accounts and Audit) Rules, 1985;

(c) whether the audit report and the annual accounts were approved

by the Registrar prior to its being placed before the General Body, if so, the details thereof;

(d) if not, the reasons therefor; and

(e) whether any action has been taken by Government against the Managing Director, NCCF for these irregularities?
