THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHR! SUKH RAM): (a) and (b) The Departmental enquiries against 3 Regional Managers have not been completed so far.

The CBI in its report relating to the irregularities in the supply of pulses by the NCCF to the Food Corporation of India had not recommended any action against the Controller of Accounts and Finance. Therefore, the NCCF did not consider it necessary to keep him under suspension and revoked his suspension on 17-5-88. NCCF however decided, in consultation with Central Vigilance Commission, to chargesheet him for imposition of minor penalty. He has been posted to the Head Office being the senior most officer in the Accounts.

(c) The chargesheet was framed in the meantime CBI have taken up investigation into the matter.
