arrested followed by the arrest of six *I* other and has also taken measures to prevent reoccurence of such incidences.

(e) Internal distribution of imported edible oils under Public Distribution System is the responsibility of the State Governments. The .laws to check mal-practices in trade as also blackmarketing and adulteration etc. in respect Of edible oils are also enforced by the State Governments. It is for the State Government to conduct an independent enquiry.
