THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY. (SHRI M. ARUNA-CHALAM): (a) Though there have been complaints about delay in refund of advance deposits no specific complaint about non-refund of advance deposits by the company has been brought to the notice of the Government.

(b) and (c) The Andhra Pradesh Scooters Ltd. is a state Government project. However, as informed by the company, they are having financial constraints in refunding the advance money as the funds are largely locked up in inventorics. The company is negotiating with its Bankers/financial institutions for financial assistance. The company has indicated that refunds will be made soon after the sanctions are received from the banks/financial institutions.

Efforts to promote ancillary Industries In villages with the cooperation of Industrialists

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNA-CHALAM): (a) and (b) The Government had convened a meeting of industrialists on Rural Industrialisation in the context of the various schemes of the Department of Rural Development. At this

meeting it was suggested that manufacture of par's components and sub-assemblies could be farmed out to industries in the rural area. Similarly the large industries could also help market products manufactured in the Rural Sector. The discussions were preliminary in nature and industrialists have been requested to specific proposals for consideration of Government.
