THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AFFAIRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FA-LEIRO): (a) and (b) The criteria for opening a bank branch in the

rural arid semi-urban areas are spelt out in the Branch Licensing Policy for 1985-90. The policy is applicable to all the States and Union Territories and envisages a coverage of 17,000 population by one bank office in the rural and semi-urban areas of each development block and availability of at least one bank office within a distance of 10 kms. from every village. In the hilly tracts, sparsely populated regions and tribal areas, the population coverage norm is relaxed from 17,000 to 12,000/ 10,000. Branch expansion in urban/ metropolitan centres is considered by RBI on the basis of proposals submitted by banks keeping in view the need of the area, viability of the proposed branch and other relevant factors.
