

THE MINISTER OF COMMENCE (SHRI DINESH SINGH): (a) The provisional figures of imports released by DGCI&S, Calcutta, do not show a general decline in our imports in 1987-83 as compared to 1986-87 from the countries of South East Asia. However, there is a fall in imports in this period from Japan and Indonesia. The fall in imports from Japan would depend on a combination of factors including the high yen-induced prices of Japanese products.
