Export of electronics and electrical goods

Will the Minister of COMMERCE be pleased to state: >

(a) whether it is a fact that electronics and electrical goods worth more than Re.

300 crores are being currently exported per year in the form of components and in assembled forms;

- (b) if so, what is the percentage of these goods exported both in private and public sectors during the last two years;
- (c) what are the main items which have earned the country the highest foreign exchange and what incentives are being given to this trade for the export of electronics/electrical goods for the next two years?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRIP R. DAS MUNSHI): (a) Yes, Sir.

(b) and (c) The main items of exports include electric storage batteries, conductors and cables, power generation, transmission and switching equipment, electrical appliances, instruments, electronic, components control instrumentation, professional electronic equipment, consumer electronic items and computer software. The exports consist of components and assemblies made out of these components from both the Public and Private Sector. Data is not, therefore, as such maintained in regard to exports exclusively from each Sector.

The incentives which have already been extended to this trade include the facility of import replenishment Licence, Cash Compensatory Support, Duty Drawback, Direct Tax benefits besides duty free imports of capital goods and production inputs under the Scheme of Export Processing Zone and 100 per cent Export Oriented Units. Duty Free import of inputs is permitted under the scheme of advance Special scheme; have licensing scheme. been formulated to encourage the export of computer software permitting the import of hardware at concessional rates of import duty, exemptions from the MRTP Act and unified clearance procedures for projects.
