The Self Employment Programme for Urban Poor (SEPUP) introduced with effect from 1.9.1986 is being implemented by the public sector banks and covers all metropolitan, urban, and semi-urban centres. The physical target for each centre is one beneficiary for every 300 population of the city]town as per 1981 census. 30 per cent of the target is reserved for Scheduled Castes/Scheduled Tribes beneficiaries both number-wise and amount-wise from financial year 1987-88. To be eligible for assistance, applicant should be a permanent resident of the centre where the

programme is being implemented and his family income should not exceed Rs. 6001-per month. Depending upon the unit cost, assistance not exceeding Rs. 5,0001- is available to selected beneficiaries. 25 per cent of the loan amount is provided as subsidy by the Government.
