Unutilised food stocks lying at budge bodge West Bengal

431. DR. BAPU KALDATE: SHRI YASHWANT SINHA: SHRI SATYA PRAKASH MALAVIYA:

Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether Government have taken note of the food stocks lying unutilised at the Food Corporation of India godown at Budge-Budge, West Bengal since October 30, 1987;
 - (b) if so, what are the details thereof;
- (c) whether these stocks have been allocated to the West Bengal Government; and
- (d) if so, whether these food stocks have been damaged due to their non-utilisation?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI D. L. BAITHA): (a) Yes, Sir.

- (b) The stocks could not be issued due to closure of the depot following inter-union rivalry. The dispute stands settled now and the depot has been re-opened.
- (c) The stocks found fit for issue stand allotted to the West Eengal Government.
- (d) Due to closure of the depot some stocks of foodgrains have slided down to lower category. These stocks can, however, be issued after due cleaning upgrading.

Neem based Insecticides

- (a) whether it is a fact that Neem had been used traditionally in the country for centuries as a pesticide;

- (d) whether any self contained document likely to be prepared on the subject for knowledge of general public?

(d) The ICAR Institutes have already issued bulletins for farmers on the utility of Neem.
