Training Programme organised through the Rural Electrification Corporation

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRI KALPNATH RAI): (a) Yes, Sir.

- (b) The Programme envisages imparting training in the matter of installation of efficient irrigation pumping systems for 900 supervisory and field level officers of State Electricity Boards, State Governments and Banks etc. So far 13 programmes covering 286 officers have been conducted at Hyderabad (Andhra Pradesh) and Nasik (Maharashtra). Each of these programmes included a cross section of participants drawn from different States.
- (c) The Training Programme has been very well received by the participants and their sponsors.
- (d) and (e) The sponsoring agencies are advised to depute only the concerned field officers to attend the training prog rammes so as to ensure that on getting trained, they are utilised for dissemination of knowledge and transmitting guidance to the farmers.

Chartering of helicopter service by ONGC for offshore operation

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHR1 BRAHM DUTT)- (a) Besides its own three helicopters. ONGC is Charter-hiring helicopters from M|s Pawan Hans Ltd. (PHL) M|s Delhi Gulf Co. and Indian Air Force for its offshore operations. The period of contract with M|s PHL is from 6.10.86 to 31.3.90.

- (b) In the last 4 years, there has been only one accident on 12th August, 1988 involving a helicopter of Pawan Hans Limited fa which 10 persons died. None of these was ONGC employee.
- (c) The control of operations of heli copter, charter-hired by ONGC is with the concerned contractor who coordinates with authorities like Air Traffic Control, National Air Port Authority etc.
- (d) The investigation of such types of accidents is the concern of Ministry of Civil Aviation.
