Financial power with N.T.P.C. for boosting its operation

3675. SHRI SHIV PRATAP MISH-RA: Will the Minister of ENERGY be pleased to state:

- (a) whether the National Thermal Power Corporation has been vested with a number of financial powers by the Cen tral Government to give impetus to its operation;
- (b) if so, what are the details in this regard; and
- (c) the time by w'nen a decision in this regard is likely to be taken?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRI KALP-NATH RAI): (a) to (c) The National Thermal Power Corporation have, in the light o'f the Memoranda of Understanding concludej with ths Corporation for the years 1987-88 and 1988-89, been delegated powers which include sanction of advance expenditure on new project proposals, release of foreign exchange upto specified limits in cases of committed multilateral and bilateral assistance tied up for projects and sanction of incentives etc., within the guidelines laid down for this purpose.
