all the consumers in the Gujarat area so that our gas does not go waste. At present, more than 5 million cubic metres of gas is burnt.

SHRI GHULAM RASOOL MATTO: That was my point.

MR. CHAIRMAN: Next Question. Question No. 387.

Supply of indigenous part for Maruti car by the local manufacturers

*388. SHRI DHULESHWAR MEENA:

SHRI BIR BHADRA PRATAP SINGH:†

Will the Minister of INDUSTRY be pleased to state:

- (a) whether it is a fact that Maruti Udyog Lamited has started using pumps manufactured by Rico Auto Industries Limited for their Marauti cars:
- (b) if so, what are the details in this regard;
- (c) what are the names of the companies which are supplying indigenous parts to Marauti Udyog Limited and whether a number of complaints have been received from the dealers as well as from the owners of Maruti cars to effect that there are major defects in the parts supplied by the local manufacturers;
- (d) if so, what steps are being taken to maintain the quality of the vehicle; and
- (e) whether it is also a fact that during the recent monsoons there have been lea-

kages in the Maruti vehicles and if so, what steps have been taken to rectify the faults?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO) (a) No, Sir.

- (b) Does not arise.
- (c) to (e) A statement is laid on the Table of the House.

Statement

At present Maruti is obtaining indigenous parts from about 360 ven dors whose names are given in the Annexure. (See Appendix CXLVII Annexure 127) Maruti cars have been well received in the market. There have been some complaints about the quality of a few indigenised parts including some complaints about water leakages during the recent monsoons. These are being attended to by Maruti Udyog Ltd. and their venders for rectification and maintenance of quality standards.

SHRI BIR BHADRA PRATAP SINGH: Sir, I have always stood for indigenisation and this is a welcome step. But indigenisation does not mean fall in standards and quality and it is all the more serious when we have a product like the Maruti which we wanted to provide at a cheaper cost. May I know from the honourable Minister what precautions he is going to take against those vendors for selling spurious or duplicate parts?

SHRI J. VENGAL RAO: Sir, we are maintaining a high quality equal to the imported ones from Japan and for this. we have appointed a Committee to check up the quality of the indigenous parts.

SHRI BIR BHADRA PRATAP SINGH: Sir, probably the honourable Minister does not follow the question in the spirit in which I put it to him. So far we had been importing from Japan and it is all right and there was complaint about the quality of those parts that were available. But the general complaint now is that the parts that we manufacture here in India are not good though I am glad that about sixty

cent parts are Indian parts. My question is very simple. You have appointed these 360 vendors. I want to know whether you are getting manufactured the parts according to the standards that you have laid down. I understand that those vendors are selling spurious or duplicate parts. What measures or steps are you going to take to ensure that the parts to be sold through these 360 vendors are genuine parts?

SHRI J. VENGAL RAO: At present the indigenisation of the Maruti car is up to 80 per cent. I may inform the House that these 363 companies or units—are supplying the parts. For quality control we have appointed a Division—and the General Manager of that Division is a person who has worked with the General Motors of the U.S.A. for 20 years. Therefore there is a division to check up quality control.

SHRI BIR BHADRA PRATAP SINGH: Sir nov learned Minister does not learn anything or forget anything 1 am sorry to say that the question has not been answered. My question is a_8 to how spurious parts are permitted to be sold in the market. That is the basic question.

SHRI J. VENGAL RAO: I can assure the hon. Member that we are not purchasing spurious parts.

श्री विठ्ठलराव माधवराव जाधव : सभापति महोदय, मैं आपके माध्यम से मंत्री महोदय से जानना चाहना हूं कि मारूति उद्योग इस देश के मार्वजनिक उद्योगों में एक बहुत ही महत्वपूर्ण उद्योग है मगर श्रभी कुछ सुनों में ग्रारहा है कि मारूति उद्योग में कोई एक जनरल मैंनेजर जो 5 साल के लिए परमानेंट है, आफ्टर,रिटायर-मेंट नियवत करने के बाद मा रूति उद्योग में दो सी-तीन सौ कारों के स्पेयर बाजार में बिकी हो गए ग्रीर वहां के कामगारों में बहुत बड़ा असंतोष भड़क रहा है और यह भी सूना जा रहा है कि अगर ऐसी ही परिस्थिति रही तो मारूति उद्योग की जो क्वालिटी है ग्राज हमारे देश में वह थोड़े ही दिन में खतम होने जा रही है। उसके सिवाय भीर भी बहत सी बाते हैं कि जो नीचे

प्राच्छे-प्राच्छे ग्राफिसर हैं उनको बदला जा रहा है क्योंकि उनका जो इन्टरस्ट है वह सेफ-गार्ड नहीं कर पाते। क्या यह सच है कि मारूति उद्योग में डिटिरियोरेणेन शुरू हो चुका है ग्रीर ग्रच्छे पार्ट्स खतम होते जा रहे हैं ग्रीर अच्छे पार्ट्स खतम होते जा रहे हैं ग्रीर उसमें काफी चोरियां भी होती जा रही है ग्रीर ग्राफिसर्ज को भी हु स किया जा रहा है ? मैं मंत्री महोदय से जानना चाहता हूं कि क्या यह सच है ग्रीर ग्रगर सच है तो क्या कदम उठाए गए है ? क्योंकि मेरे पास जो मारूति कार है उसकी कन्जम्मन 12--13 से ज्यादा नहीं ग्रा रही है जो कि कहा गया कि 20--21 किलोमीटर होगी।।

SHRI J. VENGAL RAO: Sir, I cannot answer his first question about the harassment of officers. I will be able to answer it if you permit a specific question about it. About the fuel inefficiency, if he sends a complaint, I will ask them to test his vehicle.

SHRI VITHAL RAO MADHAVRAO JADHAV: Sir, my question has not been answered. It is very much relevant to this question. The hon. Minister should reply to this question.

MR. CHAIRMAN: You are asking about the General Manager, The question is about the spare parts.

SHRI VITHALRAO MADHAVRAO JADHAV: The question is about the mismanagement in management Is the General Manager or anybody else held responsible for it?

SHRI J. VENGAL RAO: Sir. this unit has been earning profit since the first year onwards. It has declared 5 per cent dividend also. How can you say that it is a bad unit?

श्री बिठठ्लराव माधवराव जाधव: सर, कहो कुछ, करो कुछ--ऐसा चल रहा है। मैं कुछ पूछ रहा हूं ग्रीर मंत्री जी क्या जवाब दे रहे हैं।

SHRI YASHWANT SINHA: The basic concept behind launching this Maruti Car

Project was to provide a people's car a fuel efficient car, a cheap car and a good car. Now all these objectives with which this project was started appear to have been lost. Neither in terms of the price, nor in terms of fuel efficiency, nor in terms of efficiency, has the Maruti car been able to maintain any standard. In view of the complete failure of this project to achieve its objects, what does the Government propose to do?

SHRI J. VENGAL RAO: Sir, original thing is of the people's car, and because of heavy taxation on this car, the price has gone up.

SHRI T. CHANDRASHEKHAR REDDY: Now, a rich man's car.

SHRI VITHALRAO MADHAVRAO JA-DHAV: It is not a common man's car.

SHRI LAXMI NARAIN: Will the hon. Minister be pleased to state whether it is a fact that the officers there are divided, into two groups and that is the main reason for the deterioration?

SHRI J. VENGAL RAO: Sir, it is one of the best managed companies. There is no deterioration.

MR. CHAIRMAN: Shri Kamal Morarka.

SHRI SUBRAMANIAN SWAMY: Sir. why torture the Minister?

SHRI J. VENGAL RAO: If you put a supplementary, I will answer.

SHRI SUBRAMANIAN SWAMY: Sir, he has given me permission.

KAMAL MORARKA: SHRI Sir. I again refer to the original question put by the hon. Member and the answer given by the Minister Sir he has given a long of parties who are supplying spare parts. Sir the concern of the hon, Member who put the original question and my concern is about the rapid deterioration that takes place when indigenisation takes Even when the Ambassador and Fiat cars came to India, in the beginning the quality was not so bad. But we observe through experience that with indigenisation somehow the quality control aspect is lost. We want to know what specific measures have been taken by the Maruti Management to see that spurious parts do not go into the market. It is all right to say that the Maruti management is not buying spurious parts. But the consumer is getting spurious parts in the name of Maruti. What steps the Maruti management will take, what steps the Government will take to see that the consumer is not cheated when goes to the market to replace the defective parts?

SHRI J. VENGAL RAO: Sir, they must purchase...(Interruptions) I request the hon. Members, through you, Sir, that they must purchase from the recognised dealers of the Maruti only.

MR. CHAIRMAN: Have you announced it?

SHRI J. VENGAL RAO: Sir, there are 63 dealers throughout the country, and there are 200 and odd service stations...

MR. CHAIRMAN: Have you advertised?

SHRI J. VENGAL RAO: We are distributing, we are selling spare parts to them, not to others.
