to be arranged by way of outside funds. In the case of one mill profits of the company's other divisions are proposed to be ploughed back for meeting the promoters' contribution for the scheme. However, according to the cash flows submitted by all the 11 mill companies the future profit would be ploughed back for meeting the term loan liabilities, normal capital expenditure as also augmenting of the working capital base.

Effects of fencing along Indo-Pak border

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AF-FAIRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FALEIRO): (a) The Shipping Credit & Investment Co. of India Limited has reported that it has always adopted a helpful and professional attitude towards both shipping companies and deep sea fishing companies. Till 10th August, 1988, SCICI has sanctioned financial assistance to 25 fishing compnies-- for acquisition of 49 deep sea fishing vessels.

(b) There is no proposal for shifting of office of SCICI to Orissa.

(c) SCICI has reported that representatives of deep sea fishing companies are not required to visit SCICI's office at Romoay, except when because of incompleteness of details furnished by the fishing companies it becomes necessary to call the companies' lepresentatives with a view to expediting the processing of their project proposals. Professional Managers of SCICI also visit the business place of such companies with a view to helping them in processing tfieu proposals.
