## Apprehension of pilot famine in the Indian Airlines

- 4110. SHRI MAHENDRA PRASAD: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:
- (a) whether it is a fact that the country is fast heading for a serious pilot-drain, causing virtual pilot famine, especially in The Indian Airlines, as reported in the Hindustan Times of August 11, 1988;
- (b) if so, what is the requirement and availability of different types of pilots in the Indian Airlines, Air India and Vayu-doot;
- (c) what is the number of pilots who have shifted from Indian Airlines, Air India and Vayudoot, if any, during the last three years to various foreign airlines; and
  - (d) what is Government's reaction thereto?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL) : (a) No, Sir.

- (b) The requirement and availability of pilots by Indian Airlines, Air India and Vayudoot is as follows:—
  - (i) By 1989-90, Indian Airlines would need 654 pilots as against the existing strength of 470 pilots.

(ii) At present the requirement of pilot of Air India is 324 as against 288 pilots working.

Information in respect of Vayudoot is being collected and will be laid on the Table of the Sabha.

- (c) In so far as Indian Airlines is con cerned, during the last 3 years, two pi lots have resigned from the Corporation. It is not known whether these pilots have joined foreign Airlines. As regards Air India, 2 pilots have joined foreign airlines during the last three years. None of the Vayudoot pilots has shifted to any for eign airlines.
- (d) Airlines and the Government do not visualise any mass exodus of pilots to foreign airlines.
