## **Revenue from Tourism**

Written Answers

4020. DR. NARREDDY THULASI REDDY: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state

(a) what are the targets of foreign revenue and their achievement from Tourism in 1985-86, 1986-87 and 1987-88; and

,(b) what are the proposals to develop tourism in the country ?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PAUL) : (a) Foreign exchange earning from tourism depends upon the total foreign tourist arrivals. Targets are, therefore, initially fixed in terms of foreign tourist arrivals and later foreign exchange earning worked out on the basis of average spending per tourist. The Planning Commission has set a target of 7 per cent growth rate in arrival during the Seventh Plan period. Foreign exchange earning is also, therefore, expected to grow at this rate. As against this the actual earnings and the percentage growth achieved during the last three years are as given below :

(b) Tourism development is a continuous process and the government has taken up many schemes for the purpose.
