Pilot-drain in the country

4272, SHRIMATI SUDHA VIJAY JOSHI: Will the Minister of CIVIL AVIA-TION AND TOURISM bc pleased to state:

- (a) whether Government's attention has been drawn to the news item which appeared in the Hindustan Times of 11th August, 1988, to the effect that Indian Airlines pilots are tempted to go to other countries, particularly in Gulf Air, employmen, and a sort of pilot-drain has developed;
- (b) if so, the grievances of pilots and the reasons for the exodus;
- (c) whether Government propose to ask the Gulf Air not to entertain their applications; if so, the details thereof;
- (d) the number of trained pilots who left India for service abroad during the last three years;
- (e) in what manner Government propose to meet the deficiency of pilots; and
- (f) what action Government propose to take to ensure that pilots are satisfied with Airlines' services and the training schedule for Air bus-320 at Toulouse is not affected?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) Yes, Sir.

- (b) As the foreign carriers are offering lucrative salaries and perks they apply in response to global advertisements.
- (c) IA is trying to obtain authentic information from Gulf Air in the matter.
- (d) During the last three years i.e 1985-86 and upto August, 1988, only two pilots have resigned from the Indian Airlines. Indian Airlines is, however, not aware whether these two pilots have joined the foreign carriers.
- (e) and (f) Indian Airlines is in process of holding discussions on the Charter of Demands submitted by the utuons. including the pilot's representative body. It is expected that the training programme for pilots for A-320 aircraft will go ahead as planned.
