#### Funds for adultt education

4004. SHRI SHIV PRATAP MISHRA; Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government monitor the use of funds for adult education in States; and
- (b) what steps Government propose to take for their proper utilisation?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI); (a) Yes, Sir. A Statement is attached (See below).

(b) Funds are being released in a financial year on the basis of utilisation and. actual performance during the previous financial year. Moreover the Centres run under various Adult Education Schemes in all the States and Union Territories are being subjected to periodic and surprise inspections.

#### Statement

The National Adult Education Programme (which will now be implemented as National Literacy Mission) is being implemented through the following agencies:

- 1. Rural Functional Literacy Projects.
- 2. State Adult Education Projects.
- 3. Voluntary Agencies (VAS).
- 4. Mass Programme for Functional Literacy.

Rural Functional Literacy Project is fully funded by the Central Government but administered by the State Governments. State Adult Education Project is funded and implemented by the State Governments.

2. As far voluntary Agencies (VAs) are concerned, there is a central scheme of grantin-aid to Voluntary Agencies under

which 75 per cent of the administrative expenditure and 100 per cent programme expenditure is being met by the Central Government and the centre-based program, me is being implemented by the agencies themselves.

to Questions

- 3. As far as Mass Programme for Functional Literacy (MPFL) is concerned, the Central Government releases funds to the State Resource Centres (SRCs) for production of literacy kits which are supplied free of cost to the student youth, non-student youth and other agencies. Besides, the Central Government also arranges training of the master trainees (NSS, non-NSS and NCC) through the SRCs.
- 4. The following procedure is being adopted for monitoring of information regarding utilisation of funds in respect of the above categories as below:—

# 1. RURAL FUNCTIONAL LITERACY PROJECT:—

Hitherto sanctions under RFLP in favour of receipt were being released in three instalments. Release of second and third instalments was conditional on utilisation of the first and second instalments and receipt of reports from the State Governments to that effect. From 1988-89, the amount under RFLP is being released in two instalments subject to satisfactory utilisation of the amount released in previous years and receipt of utilisation certificates to that effect. From this year, an additional component is being added in respect of performance of adult learners in Adult Education Centres.

# 2. STATE ADULT EDUCATION PRO JECTS:—

The Planning & Monitoring Unit of the Department of Education, however, is receiving quarterly progress report of expenditure from the State Governments under SAEP.

### 3. VOLUNTARY AGENCIES: —

The condition of sanction of funds under the Central Grant-in-Aid Scheme for Voluntary Agencies stipulates that the Voluntary Agencies receiving funds from

the Central Government have to send initially, quarterly and annual progress reports to the State Governments and to the Central Government After the projects are completed, the agencies are required to submit detailed audited accounts.

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) Allocation for maintenance of National Highways is not made on Kilometre basis but on prorata basis dependending upon the availability of resources.

(b) and (c) Physical norms of maintenance were fixed in 1968 and these are up-dated from time to time on the basis of price index.

#### Extension of Metro Railway, Calcuto
