Vayudoot services in Jammu and Kashmir

- 4160. SHRI DHARAM PAL: Will the Minister of CIVIL AVIATION AND TO URISM be pleased to state:
- (a) whether it is a fact that Government have committed to start Vayudoot services between Jammu-Poonch, Jammu-Rajouri and Jammu-Kishtwar in J. & K. State; and
- (b) if so, what are the reasons for not starting the services so far?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATTL): (a) Subject to availability of aircraft capacity, development of infrastructure and econo mic viability of operations, Vayudoot has plans to provide air services to Jammu, Rajouri, Kishtwar and Surankot in the State Of Jammu and Kashmir. At present there are no proposals to airlink Poonch by Vayudoot services.

(b) Subject to availability of aircraft capacity, Vayudoot has plans to airlink Rajouri in the immediate future. Vayudoot operations to Surankot and Kishtwar will not be possible for the present as there are no operational airfields there.
