THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) to (c) At present there are six Unani dispensaries/Units under CGHS—3 at Delhi, 2 at Hyderabad and 1 at Lucknow. It has not been possible to open Unani dispensaries/Units in all the remaining cities where the CGHS is in operation owing to limited financial outlay approved by the Planning Commission for CGHS during the Sixth and Seventh Five Year Plans. Also popularity of the system and its demand by the beneficiaries is kept in view subject of course to the availability of funds, while formulating Five Year Plan,
