Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state: •

- (a) the number of CGHS Ayurvedic dispensaries/units functioning in Delhi:
- (b) the sanctioned strength and present strength of the doctors in each of the above dispensary;
- (c) whether it is a fact that some doctors who are posted in a particular dispensary are being posted in another dispensary on temporary basis;
- (d) if so, the details thereof and the policy of Government regarding transfer/posting of doctors in CGHS dispensaries; and
- (e) whether Government would take action to post these doctors to their original places of posting?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTHAND FAMILY WELFARE (SHRIMATI PANABAKA LAKSHMI): (a) There are 5 Ayurvedic dispensaries and 8 Ayurvedic Units functioning under CGHS, Delhi.

(b) The present position of doctors in Ayurvedic dispensaries/units is given below. The original sanctioned strength of doctors for the dispensaries/units have undergone changes from time to time.

(c) to (e) At times it becomes necessary to temporarily depute a doctor, posted in particular dispensary to cater to another dispensary/unit due to the doctor posted there being on leave or otherwise, in the best interest of CGHS beneficiaries. As per the transfer policy of doctors under CGHS, a doctor is transferred after completion of 3 years in one dispensary and in the case of CMO Incharge the period is 4 years.
