

Collection from education cess

2737. DR. BARUN MUKHERJEE: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the total amount so far collected on account of 2 per cent education cess, year-wise;

(b) whether this amount has been utilized for any special project(s) or is supporting the general budget of the Ministry; and

(c) the year-wise expenditure from this cess amount indicating the specific 'heads'?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD ALI ASHRAF FATMI): (a)' Receipts on account of Education Cess as reflected in the Receipts Budget 2005-06 and Expenditure Budget 2006-07 of the Ministry of Finance are as under:—

A non-lapsable fund called the Parambhik Shiksha Kosh (PSK) has been established for transferring/crediting into it, the proceeds of education cess. A provision of Rs 8,746 crores for the initial transfer to the newly created PSK has been made in the Union Budget, 2006-07 against estimated receipts of education cess.

(b) The proceeds of Education Cess are utilized exclusively for the Sarva Shiksha Abhiyan (SSA) and Mid-Day Meal Scheme (MDM) of the Government after exhausting the funds provided to these schemes by way of Gross Budgetary Support (GBS).

(c) In addition to the General Budgetary allocations, contribution of Parambhik Shiksha Kosh has been shown as a separate line item only from the Budget of 2006-07. In the financial year 2006-07, the unaudited

tentative figures of expenditure up to November 2006, recoupable from PSK are as follows.—

(e) the steps taken, if any; by Government to ensure universal coverage of schools across the country under mid-day meal scheme?
