(c) and (d) The Government of India has taken up the matter with the US Government. The US Government has indicated that India's inclusion in the "Majors List" is primarily beacause of the "large-scale diversion from illicit opium production into the illicit market. US has requested information over a period of time that diversion from illicit production has been reduced to a modest problem.

## Restoration of Connemara public library building in Chennai

\*390. SHRI K.P.K. KUMARAN: Will the Minister of CULTURE be pleased to state:

- (a) whether the ASI has any proposal to restore the world famous Connemara Public Library Building, Chennai and other places, of importance in Tamil Nadu; and
- (b) if so, the details thereof including the estimated cost of projects and estimated time for completion, project-wise?

THE MINISTER OF CULTURE (SHRIMATI AMBIKA SONI): (a) and (b) Archaeological Survey of India has restored the Connemara Public Library Building at Chennai as a Deposit Work. The major items of restoration carried out included:

- relaying of damaged tiled roof in central portion and Madras terrace roof on the aisle portion,
- mending and replacement of missing pieces of stained glasses with floral designs on vaulted roof and wall panels.
- restoration of stucco work and architectural features insides the building, and
- restoration of damaged art work on the ceiling.
- The total cost of restoration is Rs. 1,02,21,079/-.

The details of the conservation/restoration works under taken by the Archaeological survey of India in Tamil Nadu during 2006-07 is given in the statement.
