## CBI Enquiry against Oil Companies

1617. SHRI SANTOSH BAGRODIA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Central Bureau of Investigation has recently registered a preliminary enquiry against some officials of three Government owned oil companies for extending credit facility to eight private airlines, as reported in the Hindu of 14th June, 2000;
  - (b) if so, whether this includes as international airlines also;
  - (c) whether proper bank guarantee securities were obtained;
  - (d) if so, the details thereof; and
  - (e) if not, the reasons therefor?

PONNUSWAMY): (a) to (c) With the commissioning of additional refining capacity in the country during the year 1999-2000, country has become self sufficient to meet the demand of diesel. It has, therefore, been decided to permit use of diesel as fuel for power generation. Additional demand of diesel for this purpose has not yet been finalised.
