Allocation for Bihar under RGGVY

†505. SHRI ALI ANWAR: Will the Minister of POWER be pleased to state:

- (a) the amount allocated to the State of Bihar under the Rajiv Gandhi Gramin Vidyutikaran Yojana;
- (b) the district-wise details of the allocated amount;
- (c) whether this allocation is according to the average national allocation;
- (d) whether Government propose to accord priority to the backward State like that of Bihar in such allocations which are far behind in the matter of consumption of power from the point of view of national average; and
- (e) if so, the details of the schemes of Government in this regard?

THE MINISTER OF POWER (SHRI SUSHILKUMAR SHINDE):

(a) to (c) So far 29 projects for Bihar are sanctioned at the cost of Rs. 1694.38 crore. In addition to this, 9 projects are approved 'in-principle'. District-wise fund allocation is enclosed as Statement—I (See below).

(d) & (e) The states, including Bihar, having low level of village electrification as compared to the national average have been accorded priority for providing access to electricity for household electrification under RGGVY.

Bihar State Government has, so far, submitted Detailed Project Reports (DPRs) for 38 districts involving an outlay of Rs. 3349.15 crore. 29 projects have been sanctioned for 29 districts. Further, 9 projects have been given 'in-principle' approval.
