SHRI DIPEN GHOSH: You ask the industrialists to deposit...

SHRI SHANKER SINH VAGHELA: For employees it is excess money. For labour it is not excess money ... (Interviuptions) ...

SHRI DIPEN GHOSH: This is compensation for the price rise already recorded.

SHRI NARAYAN DATT TIWARI: I seek co-operation of all Members. As you said State Governments are also worried about this. This is done already in some States. Half of the money or a quarter of the money or the whole of the amount is deposited' in the provident fund. I am thankful to those employee organisations which agreed to this. Therefore, we have to create a proper climate not in the spirit of some confrontation but in a spirit of understanding the economic reality of the situation. It was not to make a delay. One-and-a-half months ago in February we had the Budget. I don't think, Mr. Dipen Ghosh in his erudition: can grudge this delay. Rather, we should all combine to see to it that we do not all contribute to. any price rise so that we have to pay all this D.A. and the money much needed for development goes for paying the dearness allowance.

Shri Kailash Pati Mishra's point, I think, has already been taken care of. Mr. Sukomal Sen mentioned the same more or less.

I think, I have covered all the points. I am very thankful for all the co-operation I have received from the employee organisations. I hope that in future also they will consider it because. I know, the Government employees of this country are as much aware of the difficulties that we are facing that the country is facing. It is not Narayan Datt Tiwari who is facing the difficulties. I hope that they are also similarly responsible as we are, and they will certainly think over the matter and do whatever they can.

II. Explosion in Jeeven Bharti Building New Delhi

THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): Now, Mr. Chintamani Panigrahi Minister of State for Home Affairs will make a statement regarding the explosion that has taken place in Delhi.

SHRI DIPEN GHOSH (West Bengai): Sir, I am on a point of order. The question is that the Minister of State for Home Affairs is going to make a statement on this incident of explosion in Delhi It was raised in the morning. Normally the procedure is that when a Minister makes a statement, at least one hour or two hours in advance notice is given and Members are informed about the time and the subject on which the Minister would like to make a state-Actually the Department of Parliamentary Affairs must have been informed by the Ministry of Home Affairs that the Minister is going to make a statement. So, the Department of Parliamentary Affairs should have taken note of it and circulated it

THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): It should have been circulated. Why not?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHINTAMANI PĀNIGRA-HI): I take note of what hon, Shri Dipen Babu has said

THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): What is your point of order?

श्री श्रश्विनी कुमार (बिहार): मेरा प्वाइट ग्राफ ग्राइंर यह है कि यदि पूर्व सूचना मिलती तो श्राइवाणी जी स्वयं यहां उपस्थित रहते जिन्होंने सबेरे यह विषय उठाया था। इस समय वह उपस्थित नहीं है क्यों कि दूसरा इनगेजमेंट था। ग्रगर पहले से सूचना होती तो श्रधिक सुविधाजनक होता। मैं श्रापके माध्यम से लीडर ग्राफ दी हाउस ग्रीर पालियामेंटरी ग्रफ्यर्स मिनिस्टर से निवेदन करूंगा कि भविष्य में पूर्व सूचना देने की क्या करें।

THE VICE-CHAIRMAN (SHRI B. **SATYANARAYAN** REDDY): taken note of it.

SHRI CHINTAMANI PANIGRAHI: Mr. Vice-Chairman, Sir today an explosion took place in Delhi in the Jeevan Bharti Building. Hon. Members in the morning rightly expressed their grave anxities to know about this incident. Whatever information is readily available we thought that we should share the anxities of the hon. Members. - Facts regarding the incident of explosion in Delhi Administration, are as follows:

"At about 12.10 hours today (10-5-88) a bomb exploded in the Reception area of the Citibank located in new LIC building called "Jeevan Bharti" near Regal ciema in Connaught Place. Citibank is an American bank, The explosion caused considerable damage to the bank premises. One person-Satish Chaudhary, resident of NOIDA died in the explosion others were injured and 1 of them is in a critical state. Out of these 14 persons 8 have been discharged. regards the in-patients, 5 are in Ram Manohar Lohia Hospital and 1 Lok Nayak Jai Prakash Hospital. of the injured persons were employees of the Bank and others were outsiders.

The case has been handed over the Crime Branch of the Delhi Police The Bomb Disposal for investigation. Squad and Forensic Experts are examining the scene of occurrence.

All the injured are Indian nationals and the identity of all of them except 1 person who is unconscious a serious condition, has been established."

GHOSH: DIPEN SHRI you go through the Statement, you will find that this is not at all a statement. In fact, the Delhi Administration had sent a note stating the facts and the Minister has incorporated a sentence handwriting above that note that 'I rise

to make a statement'. Even the Minister had not taken time-rather had not taken labour-to prepare it in the form of a statement and make it in the form of a statement. This betrays the lackadaisical attitude on the part of the Union Home Ministry to take note of such a serious situation that had occurred Delhi today morning. From this one can ask no clarification because perhaps by this time more facts have come to the tickers of any of the news agencies available in the Parliament Library. So my first point is what made the Union Home Ministry not to go 'a little further and study and have an indepth examinaof the situation and fledged statement a fuli on the insince it had got at least from the time of occurrence to the time making the statement more than hours.

· · Yesterday we had an occasion to seek certain clarifications in connection with the statement made by the Home Minister on the Haryana incident. There an information was given to Parliament and I quote.

"In the background of that incident in Haryana, a general alert has been issued to all neighbouring States."

SHRI ASHWANI KUMAR: What? General? Red alert.

SHRI DIPEN GHOSH: But here in the Statement is written like this. general alert has been issued to all neighbouring States." I do not know-and I wonder-what type of alert was actually issued to Delhi authorities and what steps the Delhi authorities had taken on the basis of such alert notice given by Government. This is the crux of problem. When an incident takes place, the Government says such and such thing has been undertaken and such alert notice has been given all authorities have been alerted. And next day such things happen that the people if not the culprits also, do not take care of the word 'alert'. Even after giving this general alert this type of incident could take place in the heart of a city like Delhi. Only today morning in reply to a question it was replied that the strength of [Shri Dipen Ghosh]

the Delhi police category-wise is indicated below. I quote "Commissioner of Police-1 Additional Commissioner of Police-9 Deputy Commissioner of lice-47, Asstt Commissioner of lice-165." This is upto Asstt. Commissioner of Police. I need not quote other categories. I don't think any city in our country may be anywhere in the world I do not know, but I know of mv country has such a strong police force as in Delhi. Yet, such things happen after the general alert is given. So it also betrays how inefficient this Government is to maintain an ordinary type of law and order situation even in a city like Delhi.

Again in vesterday's statement, it was stated I quote: "The police set-up being reorganised and better arms equipment have been provided. This has already started yielding results." not know in what way this has already started yielding results. In what In increasing the number of killings, in creating more situations of bomb explosions? I don't find the learned colleague of mine on the other side now. Yesterday while seeking....

SHRI VISHWA BANDHU **GUPTA** (Delhi): Surely many learned persons are on this side.

SHRI DIPEN GHOSH: While seeking clarifications on yesterday's statement that learned colleague sitting on the other side, very vocal collegue, demanded resignation of Mr. Devi Lal. I wonder whose resignation he would demand today in the background of this situation.

SHRI KALPNATH RAI (Uttar Pradesh): Who demanded? Nobody demanded.

SHRI DIPEN GHOSH: Who demanded yesterday it was on the records also. It was in the newspapers also.

SHRI KALPNATH RAI: No no, not in this House.

SHRI DIPEN GHOSH: If you challenge, I will produce.

SHRI KALPNATH RAI: Mr. Dipen Ghosh, nobody from this House demanded ..

SHRI DIPEN GHOSH: Sir, this is sheer inefficiency on the part of Central Government to tackle the situation and the more this Government will be in power, this party, this Congress (I), the more such situations will occur in our country, in Delhi. So, this is yet another reason for which this Government must quit.

SHRI A. G. KULKARNI (Maharashtra): Mr. Vice-Chairman Sir in the backdrop of yesterday's discussion and ghastly murders in Panipat and Amritsar, today's incident particularly in the heart of Delhi is something tragic. Yesterday we expressed our anguish and today also we have to express our double anguish, or more anguish whatever word the Minister likes. But, Sir, it seems that this horrible news in the backdrop yesterday's operation brings out certainthe issues to how common man reacts to the incidents happening either in Amritsar or Delhi or Darjeeling. I don't understand. Yesterday, I had made a mention of this. It is a totally demoralised population in this country because of the inadequacy, laxity of the Government's effort to meet the terrorists' challenge. As my friend yesterday also was very vocal, it is not only the terrorists' challenge it is the challenge by mini-mafia who are violently acting either for money or for some other purpose. I do not know whatever it is. I think, Sir the entire blame goes to the Delhi Administration. I will not take any political lines as Mr. Dipen Ghosh says that this Government should resign and we should have elections. We will have elections 1989 it in and is to you to fight the elections. But the Delhi Administration is totally inefficient because, Sir. as we see whose police are there. I do not know but when I leave from my home, there are four police up to Parliament posts on the road House. I do not go more outside cause of my age but the point is that They have there are four police posts. got their guns. Yesterday, we heard the discussion and the mention of the quality

of the arms you have given to the Delhi police. It was Mr. Arun Singh the ex-Defence Minister and Mr. P. Chidambaram I do not want to comment on what-Mr. Chidambaram replied but Mr. Arun Singh was quite justified that the present. guns, whatever they are SLR etc., they are only pipes. They have got nothing. If you really want to save this country and meet this terrorists' challenge, sophisticated arms to meet what these terrorists have got have to be acquired and delivered. You are only delivering what you are collecting from these terrorists and handing over either to the Puniah or to someone else. I would like to know from the hon. Minister whether these sophisticated weapons are necessary for this purpose. Secondly, every bank has got security arrangements. Whatever the Finance Minister has informed us previously, every bank got its security arrangements. The Citi Bank, a very rich American bank a security arrangement. any enquiry been made? There is a point Sir. My good friend, Mr. Panigrahi is a very sweet man and is a very good friend of mine. But, Mr. Panigrahi, statement which you have issued is something which reflects on the working of your Ministry. The statement is entirely a report of the Delhi Administration and you have only said I rise to make this statement and that has been xeroxed. At least that should not have been done. If you want to camouflage something do it cleverly. At least cleverness is quired . . . (Interruption's) . . .

SHRI VISHWA BANDHU GUPTA: But he is a sweet man. He is not a clever man.

SHRI A. G. KULKARNI: He is a clever man. You do not know. He is a Professor. You are of new vintage. We are of old vintage. (Interruption). What I want to know from him is that we see police force on every road. What they are doing? They could not trace that somebody is carrying the bomb or whatever it is. What was the intelligence? Is there any intelligence agency i_n Delhi of the Home Ministry or the Delhi Administration? Do you go around the roads or

your entire approach is only towards Punjáb and Amritsar and you do not know, what is happening near Delhi or in Delhi itself? So Sir, I think, security arrangement in the bank must be there. What has happened to that? And the Delhi security police, whatever they are, they have to be probided with soplisticated arms. Lastly I just want to make the last observation about the reaction from the Home Ministry. Yesterday we had expressed our deep freelings of heart on these matters but my feelings or Mr. Kalpnath Rai's feelings or Mr. Dipen Ghosh's feelings have a limited role. Actually, it is the common man's feelings that we should take note of. When this comes in the press tomorrow morning, the common man will be in panic. He will lose faith in the administration; he will lose faith in the total system of Government working and ultimately he will lose faith in democracy itself. So the time has come when the Government has to apply its mind to the totality of the perspective.

Lastly I come to the aspect of suspicions. Some people may say it is the Punjab terrorists. I was talking with many hon. Members in the Central Hall about this. There are talks that the Mujahideen problem in Afghanistan may have some connection in this. They want to destabilise and create disturbance in Delhi or any other big city because they want to retaliate against Americans And and India are becoming fighting grounds for America and the CIA and Pakistan and Mujahideen. The Minister may please to us whether any foreign agencies have employed some people to destabilise this country. Already in this country we are having many confusions because of many things. Dust is raised on non-issues, issue and so many other problems. On this matter, I want to know categorically from the Minister whether there is any foreign hand in this. I want to know particularly whether there is any collusion between Pakistan and Afghan rebels of Mujahideen cause it seems to be one of the plausible reasons.

श्री ग्रश्यिनी कुमार: माननीय उप-सभाध्यक्ष महोदय, कल हमने पानीपत की घटना पर इस सदन में चर्चा की । म्राज उसी प्रक₁र की घटना के ऊपर चर्चा करने के लिए सदन ग्र⊹कस्मिक यहां इस समय बैठा है, पूर्व-नियोजित नही था, एक दर्घटना हुई है। नैने कल भी निवेदन किया था, पिछले सप्ताह मैं बंजाबं घुम कर ग्राया, वहां ग्राम चर्चा का विषय था कि अन्तिसर श्रौर गुरुदासपूर जिला • हिन्दुग्रों से खाली हो चुका है, ब्राज था कल अमृतसर में दुर्घटना होगी, आगे देश के कोने-कोने में दुर्घटा जाएगी । कल मैंने सदन के सामने यह विचार रखे, दुर्भाग्य से वह सत्य ही दिख रहा है ग्रौर यह देश के लिए अत्यन्त ही दुर्भाग्य पूर्ण है। पंजाब की सनस्या ग्राज लगभग ग्राठ साल पुरानी हो गई है। ग्राज के हमारे प्रधान मंत्री ने शासन संभालने के बाद एक समझौता किया । श्राशा थी, समझौते से बड़ा विश्वास था, देश में स्राशा जगी थी कि कुछ होगा। परन्तु समझौता भी गया और समझौता करने वाला संत लोंगोवाल भी गया, जो कि देश के लिए **अ**त्यंत दुर्भाग्यपूर्ण है ग्रीर ग्राज वह समझौता एक डेड-लेटर होकर रह गया है । वह समझौता नहीं रहा है, पंजाब फिर से जातंकवाद की घटनाओं में घिर गयां है।

महोदय, जिस प्रकार की ग्राज दिल्ली में घटना हुई, दो-ढ़ाई वर्ष पूर्व इसी प्रकार की कई घटनाएं एक दो दिन में हुई थी, .स्ट्रेशन पर हुई, इधर हुई, बस स्टेंड पर हुई। एक तरह से वह इसी प्रकार की घटना थी और ग्राज की घटना के बारे में ग्रभी तक जितने तथ्य प्राप्त हुए हैं, में भी वहां जाकर देख भ्राया हूं, यह नहीं कहा जा सकता कि किसने की, **ग्राइडेंटी**फाई नही हम्रा, परन्त् जिस प्रकार की सर्कमस्टेंसियल एवीडेंस हैं, इससे यह घटना पंजाब के ग्रातंकवाद से जड़ी होने के सिवाय दूसरी होने की संभावना बहुत क्म । हो सकता है, मैं नहीं कह सकता, वह तो काइम-ब्रांच को दिया है, गृहमंत्री जी ने जैसा बताया। परन्त् जो सकंमस्टेंसियल एवीडेन्स जिस प्रकार

कीं हुई है, उससे उसी प्रकार की घटना दिखती है। दुर्भाग्यपूर्ण बात यह है कि जो श्रातकवादी होता है, वह श्रन-श्राइ-डेंटीफाइड एनिमी होता है। हमको पता नहीं, कौन श्रातकवादी है? ग्रगर शत् से लड़ाई होती है तो शत् वर्दी में होता है, शत्र दिखता है कि यह शत्र है, परन्तु दुर्भाग्य से उस अनग्राइडेंटीफाइड एनिमी का जो फोर्ट है, उसको हमने पुन:1984 की तरह से फोर्टीफाई होने की ग्रन्मित प्रदान कर दी है।

यह दुर्भाग्यपूर्ण है कि गोल्डन टेम्पल के ग्रंदर कल हमारे एक डी० ग्राई० जी० को गोली लगी ग्रौर टेलीप्रिंटर टेलीफोन .पर म्राज तक जो न्यूज म्रा रही है, कर्फ्य लगा हुन्ना 7.00 P. THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): Mr. Ashwani Kumar, you please conclude now.

SHRI A. G. KULKARNI: Mr. Ashwani Kumar, you are all along referring to Amritsar and Panipat. With due respect to you, I would tell you that it is Mr. Chidambaram's portfolio. So, how can Mr. Panigrahi reply?

THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): That is all right, His views will be conveyed to Mr. Chidambaram Yes, Mr. Ashwani Kumar.

SHRI A. G. KULKARNI: All right, You carry on Mr. Ashwani Kumar.

DR. G. VIJAYA MOHAN REDDY (Andhra Pradesh): Sir, once more we see from the statement some kind of callousness which is quite evident. A and it has been bomb has exploded described vividly by our friend because he has gone there and according to him, it should have been a time bomb. The package was kept there and the person who had kept the package has disappeared or might have disappeared or might be some where else. damage that was done was so serious and the explosion was of such an tensity that even on the eleventh floor the vibrations were felt there is an atmosphere of violence in the country which has gripped the land and disruption of the genuine forces is being attempted nationalist certain anti-national forces. I think the conflict that is viewed. properly Yesterhas to be day, Sir the entire House was of the both the Members on the Treasury Benches and on the Opposition side were of the opinion that the Government would have to take a very serious view and adopt a firm attitude in dealing with these matters. And especially as our friends have said, the intelligence has completely failed. Till now we do not know who are the culprits, even in this case also. That is why some kind of surveillance will have to be there: some effective surveillance should be there -where and how this kind of terrorists or persons belong to mafia group are moving. Why do we not take these people under preventive detention or arrest them under the Anti-Terrorist Act? Why don't you put them behind the bars? An atmosphere is developing where all kinds of forces are going to dominate in the society; all kinds of divisive forces are going to dominate, whether it is the Punjab problem or it may be of a different kind of problem. The reactionary forces are mobilising to disrupt the unity, integrity and democratic set-up of this country. We must try to take all the measures to see that we put an end to these things with a firm hand. Especially in this particular instance, the accident that Las taken place, I think, has to be taken as a warning because it has taken place in the heart of the city

and this is going to affect the morale of entire citizens of Delhi, because it has happened at a place which everybody will be visiting almost every day. That is why the entire city itself will be gripped in some kind of anxiety. And that is why, in view of the anxiety that is existing, we will have to assure that we are firm in dealing with these cases and we will be in a position to see that this city and the nation is rid of these disruptive forces.

THE VICE-CHAIRMAN (SHRI B. SATYANARAYAN REDDY): Mr. Chimanbhai Mehta. Please be brief.

SHRI ('HIMANBHAI MEHTA (Gujarat): Mr. Vice-Chairman, Sir, I would like to know from the hon. Minister whether such a thing was expected in Delhi by the Government, because in view of what is happening in Punjab and in Panipat this was to be expected. I do not want to see just in one direction. Some men talk about Mujahideens also. I know the limitations of the polce. I am not a defender of the Home Department, But such things have been happening in other countries also Right in the heart of the capital it has happened. In other countries such things do take plac!. Then, how to react? That is very crucial here. Unless we mobilize...

THE VICE-CHAIRMAN (SHRI B. SATYAN(IRAYAN REDDY): Be brief.

SHRI CHIMANBHAI MEHTA: Unless the people as a whole are mobilized and politics kept apart, we cannot put an end to this. I coking to the seriousness of the situation, ()nly one aspect should be kept in mind that terrorists have to be attacked by all the parties with a single-minded devotion. People should be made aware where sucli things are likely to happen, Every mat, is carrying something in his bag. How to know whether he is carrying a bomb on not? If the masses are aware, then they would take care whether anybody is putting something some where. But that awayeness is lacking because of factors. I won't like to go into those factors. This is the time to unite the people. There is no doubt that somebody is interested in scaring us. If you come to this conclusion, may I ask the hon. Minister what measures you are going to take against it, how you are going to mobilise the people and how you are going to take the people into confidence? These are my questions. Thank you, Sir.

efficiently and he was tem worked able to get the information within minutes. Sir my friends have drawn the attention of the House and the Home Minister to several different aspects of this incident. I would like to know from the hon Minister about the terrorists or the person who brought the bomb or the persons involved in this. Sir, I have been there myself and I have seen the place, And I do not agree with Ashwani Kumarji that it might be an act of fust somebody from Punjab It could very well be somebody else it could be some I would like to know from outsider. the hon. Minister whether it was an act by an indigenous terrorist or a foreign terrorist. Has the Ministry made some estimate of what the damage has been? In view of what has happened, I would like to know from Minister the hon. Home whether. apart from security arrangements, any special arrangements have been made in places around the part of the city to inform the police, to inform the fire brigade, to inform the bomb squad and to inform the other agencies to take very quick action in such a situation. Sir, some of my friends from the other, side mentioned that there are so many police vehicles standing around the corners and checking the people. It is a very And I agree that it is a good thing. very difficult task for the police, specially for the Delhi police. They have to be on a constant alert. This is a very vlunerable area. We live in an And we have to see open society. how this challenge can be met. One of the ways, according to me Sir; is an. communication efficient system. I would like to know whether any person was seen running away, whether any chase was given by the police and whether the communication to the police headquarters was in time. Sir, it is true that terrorists can attack They strike when they like and wherever they like and they do . not give any prior inforamation to the Home Ministry or to the police. So this is a real problem and for solving this all of us have to be involved. And

Statements

I would like to ask the hon. Minister to tell us what steps he is going to take in this matter.

SHRI KAPIL VERMA (Uttar Pradesh): Mr., Vice-Chairman, Sir, this incident is very very shocking and obviously it is creating panic, demoralisation and scare in the city because, as has been pointed out it has taken place within a mile of Parliament House and the seat Central Government. And if this can happen in Delhi, it will not only make people feel insecure and demoralise them but it is bound to have repercussions in the other parts of the country also. The Minister's statement is not very clear about background. Yesterday when we discussed the incident which took place in Panipat, we expressed our apprehensions that the terrorists are going to strike in other parts of the country also. It has to be seen whether after the red alert, the police did take at all adequate measures against any such possible attack. We want a statement from the Minister, a comprehensive statement detailing what measures he has taken to safeguard against these things. Is there necessary preparedness in the city? should seriously consider whether there is need for reorganising the intelligence services, in any case strengthening them and strengthening the police arrangements and also give them the most modern and sophisticated weapons to fight them with. Sir, in my opinion the Government should do everything possible to curb this and not allow any more incidents in Delhi because, as I said, this is bound to affect the sense of confidence and sense of security of the people all over the country. So, I want to know from the Government what special measures they have taken, the Home Department and the Home Ministry has taken. after the general alert given after the Panipat incidents and after what we have seen this morning. Thank you.

THE VICE-CHAIRMAN (SHRI SATYANARAYAN REDDY): Yes, Narayanasamy, only two minutes, please.

SHRI V. NARAYANASAMY (Pondicherry): All right, Sir, I will not take much time.

(Shri V. Narayanasamy)

Mr. Vice-Chairman, Sir, it is very clear that when the pressure is mounted on the terrorists in Punjab and Haryana, they are spreading their activities to Delhi also. Sir, I have gone through the statement which has no more details than were given by the AIR bulletin. This is like the information which was given by the AIR and it has been reproduced with slight modifications. Sir, the statement of the hon. Minister does not tell us what was the actual damage caused to the building whether the adjacent building been damaged by the explosion and how powerful the bomb was. Details on all these aspects are missing. Actually the incident took place at 12 noon and now how many people were examined and what 7.30 p.m. and the Minister has nottold Is the information furinshed by them was. All these particulars are lacking.

Statements

Sir, another important factor is that one Satish Choudhary from NOIDA, who died due to the bomb explosion, it has not been stated whether he is an employee of the bank or whether that particular person is a customer.

Then, Sir, another important aspect is that there is general fear among the people of Delhi that their life is insecure. Therefore, I would like to know from the hon. Minister that since the red alert has been given in Delhi also, what preventive measures the Government is taking to safeguard the people who are living in Delhi because they have seen some explosions in Delhi and the police has to be put on toes so that the people can be saved.

SHRI CHINTAMANI PANIGRAHI: Mr. Vice-Chairman, I share the anxiety and anguish expressed by all the hon. Members over this shocking incident, in the national capital, and in the heart of the city. We also extend our deep sence of sympathy to the families of the bereaved and the injured in this explosion. This is a very limited question on which Members expressed their anxiety in the House in the morning and as Dipen Babu and others pointed out, this is not a detailed statment, and all the hon. Members wanted that we give a detailed statement...

SHRI KALPNATH RAI: Sequence of events.

SHRI CHINTAMANI PANIGRAHI: When such an event takes place, we all are anxious to know the details, and to know what the facts are. It was only a statement based on the bare facts that were immediately available from the administration. I am also not very much satisfied, as all the hon. Members have said. It was only the bare facts which were immediately available that we have As hon. placed it before the House. Members have said it is inade. quate I agree with them. This is because the investigation is in progress and, therefore, we do not have all the details now. Members asked whether gurudwaras can be used for acts of violence. They also asked whether religion will get priority or the country will get priority.

SHRI KALPNATH RAI: Country will get priority

SHIR CHINTAMANI PANIGRAHI: These things have been discussed. There is no doubt that the country is bigger than anything. The interest of the country should be safeguarded, the integrity of the country should be safeguarded at any cost. This sentiment expressed by hon Members is shared by everybody in the country.

SHRI A. G. KULKARNI: What about the involvement of foreign elements in this?

SHRI CHINTAMANI PANIGRAHI: I am coming to that. While referring to this incident, many points have been raised by hon. Members. Shri Satya Prakash Malaviya, Shri Ashwani Kumar, Dr. G. Vijaya Mohan Reddy, Shri Kalpnath Rai, Shri Kapil Verma, Shri V. Narayanasamy and Kulkarniji have all raised many points. It was asked whether this was the work of terrorists from Punjab or by some outside forces

SHRI KALPNATH RAI: This is the work of Punjab terrorists.

SHRI CHINTAMANI PANIGRAHI: Various points have been raised I think the crime branch will surely look into all these aspects.

SHRI A. G. KULKARNI: The important question is whether you will supply them sophisticated weapons. Say something at least on this to boost the morale of the people fighting terrorism.

SHRI CHINTAMANI PANIGRAHI: As hon, Members pointed out, we have to give them sophisticated weapons. We are giving them. The communication system has been improved.

SHRI A. G. KULKARNI: Not captured from the terrorists. Purchase something else.

SHRI DIPEN GHOSH: It is available in the Chandigarh market

SHRI CHINTAMANI PANIGRAHI, I share the anxiety of hon. Members. Whatever weapons are needed, they should be

given so that the integrity and unity of the country can be safeguarded. We are doing it.

Statements

SHRI DIPEN GHOSH: The more you say this, the more is the number of such incidents.

SHRI CHINTAMANI PANIGRAHI: Shri Vishwa Bandhu Gupta asked as to when did we get the information. Our communication system is very well developed. Immediately we got the information. Whenever anything happens in any part of the country, it takes very little time for the information to reach us. Of course, there are some deficiencies in regard to the communication system. We are trying to improve it. Our friends have been saying that the citizens of Delhi are very much panicky. I assure the citizens of Delhi that they need not be panicky. Governmnet is fully alert to meet the situation.

SHRI DIPEN GHOSH: They know your capability. They are not scared of you.

SHRI CHINTAMANI PANIGRAHI: Shri Kalpnath Rai pointed out that some threatening letters have come. We have taken note of such acts.

SHRI A. G. KULKARNI: Mr. Minister. how do you say that they are not demoralised? Have you ever tested their confidence? This is totally wrong. People are certainly dissatisfied and annoyed. They doubt your credibility

SHRI CHINTAMANI PANIGRAHI: 1 do not think the Delhi citizens are demoralised as the hon. Member is saving. They are facing this challenge. This is a challenge to our nation. It is a national challenge. We are also facing it. As I said, there are some deficiencies and we are trying to overcome them. As Shri Chimanbhai Mehta suggested, we have to mobilise the people. A handful of people. with help from some foreign countries, are indulging in these terrorist activities and are trying to destabilise our country. We know it very well.

SHRI V. NARAYANASWAMY: You crush terrorism. You will get the support of everybody

SHRI CHINTAMANI PANIGRAHI: Is there any duobt? There is no doubt that we will get the support of everybody in this House as well as the people in the entire country because we want to safeguard the sovereignty, unity and integrity of the country. Kalpnathji pointed out that some threatening leters have been received by Members of Parliament and others. We are taking serious note of this.

SHRI DIPEN GHOSH. Do not take serious note. If you take serious note, there will be some more occurrences. Every time you say this, the next day some incident occurs.

SHRI CHINTAMANI PANIGRAHI: Let us hope this is not repeated.

Rather it is the earnestness of the Government which prompted us to come to the House immediately to share the anxieties of the Hon'ble Members.

SHRI DIPEN GHOSH: You do not have any capability, you cient, blatantly inefficient.

SHRI CHINTAMANI PANIGRAHI: It is there in the statement. They are all Indian nationals.

SHRI ASHWANI KUMAR: can you say that? Here it is said, "the identity of all of them except 1 person who is unconscious and in serious condition, has been established." So, the identity of one person is not confirmed.

Alleged desecration of Bhimsen Temple in Etah district

श्री **ग्रश्विनी क्**मार (बिहार): मान-नीय उपसभाध्यक्ष महोदय मैं ग्रापके माध्यम से सदन के सामने एटा जिला के पास नवरई (कासगंज) में हुई घटना की ग्रोर ध्यान ग्रार्काषत करना चाहता हूं। वहां पर नवरई ग्राम में जो कासगंज से चार किलोमीटर क**े दूरी पर** एक बड़ा प्राचीन प्रसिद्ध मदिर भीम सेन मन्दिरं है जो कि 1882 का बना हुआ है ग्रौर उस समय किसी मेजर ने वह बनवाया था ग्रीर उस समय की सरकार ने उसको 24 गांव भी दिए थे वहां पर होली के बाद के मंगलवार को एक बरंत बड़ामेला लगता है ग्रौर श्रास-पास के 100-50 गांवों के लोग एकद हीते

हैं। उसी मन्दिर के ऊत्पर 15 ग्रीर 16 श्रप्रैल की रात को एक दुर्घटना हुई प्रातः जब लोग वहां पूजा करने के लिए गए तो ऐसा लगा कि कोई व्यक्ति ग्रन्दर मूर्तियों को तोड़ रहा है। मूर्तियां टूटती रहीं ग्रीर जब लोग इक्ट्ठे हो गए तो मूर्तियों को तोड़ते हुए एक हकीमुद्दीन पुत निसरदीन रंगे हाथ पकड़ा गया। उसके साथ पांच भ्रौर व्यक्ति, थे कासिनग्रली निजाम, शमसुद्दीन, मोहम्स**द** शवी, रियाजुद्दीन गिरफ्तार किए गए। वहां जो मूर्तियां थीं भीमसेन की बहुत बड़ी मृति थी लाइफ साइज मूर्ति थी लालता महारानी की, शंकर-पार्वती की, नगरकोट बाबा की, वैष्णो देवी की, पूर्गीगरी देवी की, श्री सीता-राम की, इनुमान जी की, ज्वालादेवी की, कालिका देवी की, करौली माता की, दुर्गा महारानी की, ये सब मृर्तियां ध्वस्त कर दीं। इसके साथ-साथ ही वहां उसके बाहर 84 मन का एक घंटा लगा हुन्रा था उसको भी ध्वस्त कर दिया गया। इस सारी घटना के बोद एफ.म्राई.म्रार. हम्रा, पूलिस गई ग्रौर लोग एरेस्ट कर लिए गए। तथा पुलिस के प्रयास से ग्रौर जनता के प्रयास से वह बात ग्रागे फैलने से रोक दी गई, परन्तु जो कुछ घटनाएं वहां घटी हैं इसके ग्रागे-पीछे वह बहुत चौंकाने वाली हैं। उस मंदिर की जमीन पर पिछले 6 महीने से कुछ लोगों ने झोंपड़ी ब्रादि बनाकर अतिक्रनण **कर** लिया था। जब पुजारी ग्रौर मदिर के व्यवस्थापक उसको निकालने के लिए प्रयास करने लगे तो उन्होंने कहा कि हमको क्या निकालोगे, हम मंदिर ही नहीं रहने देंगे। इस प्रकार की श्रखबारों में खबरें म्राई हैं म्रीर कुछ लोग वहां देख कर श्राए हैं कि 20-25 युवक बराबर कासगंज से वहां म्राते ये म्रौर मृतियां को तोड़ने का प्रयास करते रहे। संब से जो दुख़द घटना है वह यह है कि हिरासत में हकीमुद्दीन नाम का जो व्यक्ति पकड़ा गया उसने जो बात कही है वह चिंताजनक है। उसने कहा है कि हमें मोहम्मद साहब का दीदार हासिल हुआ है कि मूर्तियों को तोड़ घोतो जन्नत मिलेगी। यह बहुत भयानक घटना है। वहां का जो इमाम है मस्जिद
